- ⇒ Core Translation Engine Underlying all of Chiapas EDI's translation capabilities, the core engine is capable of freely translating EDI files to and from CSV files, SQL Database tables, or XML files as well as generate fill SNIP Type 1 and 2 integrity reports.
- ⇒ Automation Engine Using simple, "snap-together" activities, Chiapas EDI Enterprise provide a toolbox for users to create full-featured business processes that integrate their EDI workflow with the rest of their business environment through SecureFTP, Email, and more.
- ⇒ **Documentation** Beyond the basic video tutorials, Chiapas EDI Enterprise has a manual that covers every feature of its engine environment


